#### ALIGNED-IBRP-053-JP:

**Previous Behavior:** No cardinality was enforced on **ibt-110**.

**New Behavior:** **ibt-110** cardinality must not be **more than 1**.

**Justification:** Aligns schematron validation with the semantic model.
